


Tip of the Month - Using ACE's Traceback Navigator



Have you used ACE's Traceback Navigator?

This tool lets you easily navigate through your ACE session, allowing you to see all the rows that feed into the current row in addition to showing you the rows that use the current row. Access the Traceback Navigator from the Calculate group of the Home ribbon. Here are some of the navigator's features:



- 1. Double-clicking on a row in the navigator takes you to that row in your ACE session. This way you can trace through all the variables in an equation and easily make changes to the variables if necessary. To get back to the original row in the navigator, you can use either the **back** button (1a) or select the row from the **Row** drop-down (1b).
- 2. The navigator can only be populated if the session has been calculated. If your navigator doesn't have the predecessor and successor information, click the navigator **calculator** button (2).
- 3. To trace an equation's components, click the **View Calc Details** button (3). The row's equation is broken into pieces and the results of each piece are shown. This is useful in debugging an equation that isn't calculating as expected.
