



Calculation Iteration Log...could be your key to improved calculation speed!

Do your RI\$K reports take a long time to generate?

While large sessions with many rows, fiscal years and uncertainty specifications can cause a slowdown, it could be that your session contains circular references. ACE can solve circular references; however, it does this by iterating to a result. This can cause a slowdown in calculation time, especially when calculating with RI\$K. You can view the number of iterations in your session by opening the Iteration Log, accessed from the Error Log drop down found on both the Home and Functions ribbon.



The Iteration Log shows which rows are participating in a circular reference and how many iterations it takes ACE to get to a solution. Rows with shared learning and rows that have DECs on them show up in the log since they take 3 iterations. Rows that must iterate 10 or more times are good candidates for study to see if you can revise the equations to reduce the number of iterations.
